**Tournament will be round robin groups of 6-10 players-Limit 50 players. All matches will be best 3 out of 5, 11 point games. Cost is \$20 if received by 3/24 and \$30 day of tournament.**

**(A Doubles event may be played at no cost if time allows)**

**Prizes:** Group "A" 1st place \$75, 2nd place \$50, "B" 1st Place \$25, "C" 1st Place \$25. In all other groups and doubles, 1st and 2nd place will receive trophies.

**Players:** If you have never played in tournaments, then you are considered "unrated". This tournament is designed to accommodate players of all levels. Unrated players are encouraged to enter. If you are unrated please come early so we can make an estimate of your playing ability. All other players will be grouped by their "Ratings Central" rating.

**Rules:** All USATT rules and regulations apply. Paddles must be USATT approved (Red on one side and black on the other). Wear dark shirt and shorts, tennis shoes or sneakers.

**Equipment:** Only USATT approved equipment will be used. One Killerspin Revolution, one Butterfly, seven Stiga Expert Roller , and two Joola World Cup DX30 tables. 40 mm 3 star+ Premium Nittaku white plastic balls.

**Check-in:** The facility will be open at 8:00 a.m.. You must check in at the control desk by 9:00 a.m...Tournament will start at 9:30 am. If you leave the tournament site after you have checked in, you must notify the control desk or be liable to default. Drinks will be available on site.
